Protecting the climate is the leading challenge of our time. ELAW partners around the world are working to ensure that communities that are most impacted by the climate crisis have a voice at the table and the tools they need to defend their rights and protect local ecosystems.

Our lawyer colleagues and their community partners are under increasing attack for defending and advancing the human right to a healthy environment. Public interest lawyers are fighting back against these attempts to stifle local efforts to protect the climate.

The following are brief reports on ELAW's progress protecting the climate and defending climate defenders in Suriname, the Philippines, Australia, and the Dominican Republic. We also describe our growing Defending Defenders Program and its work countering Strategic Lawsuits Against Public Participation (SLAPPs), and other actions that aim to silence environmental defenders.

Oil Company's SLAPP in Suriname Shut Down

A state-owned petroleum company brought defamation charges against Erlan Sleur and his organization, ProBios, for speaking out about an oil spill Erlan alleged was caused by the company.

Since 2009, when Erlan launched ProBios, the

organization has investigated many environmental and human rights abuses in Suriname. In 2022, Erlan began investigating an oil spill in the Suriname River next to an oil refinery owned by Staatsolie Maatschappij Suriname. Several days prior, a national TV broadcaster announced that an oil spill had been detected in the river, with no blame assigned or suspects identified.

At a press conference in October 2022, Erlan spoke out about his findings, stating that it is reasonable to believe that the Staatsolie refinery was responsible for the incident as it was the only producer, transporter, and processor of crude oil in the country at that time.

Shortly after the conference, Staatsolie sued Erlan and ProBios and demanded a public apology and withdrawal of the allegations against the oil company.

Serena Muntslag-Essed, a local lawyer in Suriname, defended Erlan in the case. Serena requested assistance from ELAW regarding international case law and relevant international regulations that might be applicable to the case.

ELAW shared cases from Argentina, Brazil, the European Court of Human Rights, India, Malaysia, South Africa, and the United States, and collaborated with Serena on a legal strategy to defend Erlan and reveal that this was a SLAPP meant to silence the company's critics.

Defending Climate Defenders

Oil Company's SLAPP (CONTINUED)

SLAPPs are a misuse of the legal system that impose costs on organizations and individuals working to protect communities and the environment. Defendants must waste time and resources fighting against false charges aimed at damaging their reputation. SLAPPs can have a chilling effect, dissuading other individuals and organizations from speaking out.

We are pleased to report that the court rejected the oil company's defamation claim, admonished it for making statements about its investigation into the spill without submitting evidence, and ordered it to pay the NGO's defense costs.

"I had a great experience with ELAW. The information, case law, and regulations provided significantly contributed to winning the case," says Serena.

We congratulate Serena and Erlan on defending against this spurious charge and applaud the court's decision. NGOs play a critical role in holding companies and governments accountable for environmental and human rights abuses in the fossil fuels sector.

Protecting Ecosystems and Communities in the Philippines

As the world struggles to transition away from fossil fuels, the minerals essential for that transition are in high demand. Governments are capitalizing on this demand, often at the expense of critical ecosystems and communities.

ELAW Partner Ron Gutiérrez of Upholding Life and Nature (ULAN) in the Philippines represents communities in Sibuyan Island that want to protect local biodiversity from the impacts of nickel mining. ELAW's Law, Science, and Defending Defenders teams have all supported ULAN and its community partners in this work.

Earlier in 2023, the mining company filed 19 charges of 'cyberlibel' against community members. ULAN rallied to protect its community partners, and ELAW facilitated a rapid response grant through the Environmental Defenders Collaborative (EDC) to support the defense by Ron and his colleagues. ULAN defended residents against false claims alleging robbery, grave coercion, physical injury, defamation, and more. In November 2023, the judge dismissed four of the five cases, identifying them as SLAPPs. Ron wrote, "We would not have been able to respond in an adequate and timely manner to the barrage of SLAPP suits that the company had filed against Sibuyan residents if not for the ELAW and EDC support."



Defending Climate Defenders

Australia: Communities Challenge Offshore Gas Drilling

The Burrup Hub threatens a deeply sacred place in Northwestern Australia that contains the largest collection of rock art in the world and includes the oldest known depiction of a human face, along with depictions of megafauna alive during the last ice age. Researchers believe emissions from the Burrup Hub are damaging the carvings.



ELAW partners at the Environmental Defenders Office (EDO) are supporting environmental defenders in Western Australia who oppose a massive offshore natural gas drilling project called Burrup Hub. Activists and campaigners opposed to Burrup have faced retaliation at the hands of Australian security forces as well as Woodside, a global energy company.

The project would produce around six billion metric tons of carbon pollution over its lifetime, impacting dozens of threatened marine species in marine parks and sensitive reefs. "The project's impact on the climate would be enormous," says Julia Grix, Managing Lawyer of the EDO Defenders Program.

Julia traveled to Oregon in October 2023 to meet with the ELAW Team, share EDO's work, and strengthen collaboration.

Julia shared that, in February 2023, the homes and vehicles of campaigners were raided by counter-terror police and their electronic devices were seized. Some campaigners were criminally charged and issued repressive bail conditions that bar them from associating. In addition, Woodside obtained restraining orders against some activists that prohibit them from making any reference to Woodside's CEO by any electronic means.

In addition to the escalation in the severity of the charges faced by protestors, Woodside has recently threatened to commence civil litigation against individual protesters. Further, Australia's national broadcaster, the ABC, has faced police demands to hand over footage of activists captured by journalists during a television report. Such tactics contribute to the shrinking of civic space, not only in Australia but in democratic societies throughout the world.

EDO's Defenders Program is crucial in providing legal defense for many Australian defenders facing criminal charges. ELAW is pleased to partner with EDO to share victories across borders and empower ELAW partners around the world working to protect the climate from polluting fossil fuel projects and other short-sighted schemes.

EDO shared good news in September 2023: Australia's Federal Court invalidated approval for Woodside to conduct seismic blasting for its \$12 billion Scarborough Gas Project (part of Burrup Hub) on the grounds that the offshore regulator had unlawfully accepted Woodside's plans when it knew the company had not completed its required consultation with Traditional Owners.

This followed a legal challenge by a Traditional Custodian, Raelene Cooper, an Indigenous Mardudhunera woman represented by EDO. Ms. Cooper is deeply concerned about the seismic activity's impact on Songlines, whales, and turtles, which are of high cultural importance.

Strategic Lawsuits Against Public Participation (SLAPP)

Helping lawyers defend against SLAPPs is a key part of ELAW's work defending defenders.

SLAPPs are criminal or civil lawsuits filed by powerful public or private actors against those who are working to protect the environment and related human rights. The effect of these lawsuits is to punish environmental rights defenders for their work, and to discourage further criticism or opposition. SLAPPs often involve direct or indirect violations of defenders' civil and political rights. Research shows that SLAPPs in the Global South are often brought as criminal proceedings, while SLAPPs in the Global North are typically filed as civil suits.

In both cases, the party who has filed the SLAPP uses its superior economic and political power to weaponize the criminal or civil legal process against the defender, generating a wide range of serious risks, costs, and harms that can be devastating to the defender personally, and to their work.

Both civil and criminal SLAPPs try to isolate and stigmatize defenders, turning them into public targets which may put them at risk of further reprisals. For example, defenders might be labeled as terrorists or anti-state.

The ELAW Defending Defenders Team provides legal strategy support to our lawyer colleagues to prevent and defend against SLAPPs, and helps partners access the resources, support, networks, and expertise they need.

Defending Defenders

Challenging Dirty Energy in the Dominican Republic

The 752 MW Punta Catalina power plant is the Dominican Republic's largest coal-fired power plant. Euren Cuevas at Instituto de Abogados para la Protección del Medio Ambiente (INSAPROMA) and Enrique de León at the NGO National Committee to Combat Climate Change (CNLCC) have worked for years to protect communities and the climate from this polluting project.

Euren and Enrique have worked closely with Ernie Niemi, President of Natural Resource Economics, to raise awareness among government and company decision-makers. "The risks associated with coal-fired power plants far outweigh the benefits," says Ernie.

Euren traveled to Geneva in September 2023 with a delegation of Dominican advocates (photo at right) to present a complaint to the UN Committee for the Rights of the Child, alleging that Punta Catalina is generating atmospheric pollution that violates the rights of affected children to life, development, and health, among others.

In response, the committee expressed concern about the severe impacts of the Punta Catalina power plant on human health and urged the Dominican government to take measures to reduce the pollution and protect the health of children impacted by the plant.

On the heels of this important advocacy work, the Executive VP of Punta Catalina threatened Enrique with a criminal defamation lawsuit, citing TV interviews he had done in early September about the submission to the UN.

"Enrique immediately reached out to allies to publicly denounce the lawsuit as a violation of free expression, freedom of opinion, and as an effort to impede scientific debate," says Charis Kamphuis, ELAW Attorney, who is working with ELAW's Defending Defenders Team to ensure that Enrique has the support he needs to respond to the threat and continue his important work.

Enrique cited two highly regarded scientific studies that support the concerns expressed about Punta Catalina. He declared that the lawsuit is an effort to intimidate and retaliate against the company's critics, and that it will not stop the movement from continuing to demand that the company meet with those who are affected and agree to reduce the pollution and pay reparations for the damage already caused to the environment and human health.

ELAW Defending Defenders Program

ELAW partners defend communities and ecosystems around the world. Attacks against these advocates are also attacks against the communities they represent. ELAW connects partners to resources and specialized personal and digital security services, and facilitates advocacy at local, regional, and international levels.

ELAW's Defending Defenders Program now has three attorneys with many years of experience defending human and environmental rights around the world (see profiles on page 5). Together, they:

- Respond when partners face legal or physical threats. This includes legal and strategic support, solidarity, and coordination, as well as connection to financial and other resources, allies, and organizations with specialized expertise.
- Build skills, awareness, and legal tools and resources for protection and resilience.
- Build alliances with other organizations and lawyers to strengthen the global movement that is advancing holistic protection strategies for environmental defenders.

By improving the security of our lawyer colleagues, ELAW also helps protect their community partners and the planet.


Alliance for Land, Indigenous, and Environmental Defenders (ALLIED) works to empower defenders, encourage multi-stakeholder action, and drive systemic change to address threats and barriers to the work of defenders. ELAW is a founding member and participates in the ALLIED Steering Committee and Law & Advocacy Working Group. We recently co-hosted a virtual workshop with over 50 participants working to improve communication strategies to counter stigmatization and combat harmful narratives.

Environmental Defenders Collaborative (EDC) partners with ELAW to provide rapid response funding through Action Partnership grants for legal defense and legal skill-building initiatives. Action Partnership grants can reach partners within 48 hours. In 2022 and 2023, ELAW made 19 recommendations for Action Partnership grants.

Open Briefing has a "referral partnership" with ELAW, expediting requests for support on behalf of ELAW partners seeking Open Briefing expertise on risk assessment and security planning, digital and information security, and psychosocial and well-being services. Open Briefing also helps ELAW strengthen its own information security and share Open Briefing's tools and resources with ELAW partners around the world.

Global Climate Legal Defense (CliDef) is a new hybrid legal NGO and intermediary grant maker providing legal support — including funds for lawyers — for climate defenders in hot spots where highimpact fossil fuel projects combined with repressive or risky legal environments raise the stakes for climate activism. Liberian lawyer and Goldman Prize winner Alfred Brownell is the Founding President, and, along with executive director Betsy Apple, leads a team of lawyers who coordinate legal services and funds around key climate cases globally.

Hugo Che Piu is an attorney and the founder of Derecho, Ambiente y Recursos Naturales (Law, Environment & Natural Resources; DAR). He is an innovative advocate for transparency in Peru's forestry sector. He works on combating environmental crimes in the Peruvian Amazon and takes the lead at DAR on governance and policy issues tied to illegal logging, wildlife trafficking, and illegal mining.

ELAW has collaborated with Hugo's organization for almost 20 years.

Hugo identified focus areas for his 10-week visit, including building DAR's organizational strength and enlisting the ELAW Team and other experts to participate in discussions and field trips tied to energy transition in the Amazon, forest protection, national policy to advance renewable energy, evaluating proposed infrastructure projects, advocating for good governance, protecting Indigenous environmental defenders, and more.

New Resource to Tackle Plastic Pollution Globally

We are pleased to announce the launch of the **Global Plastic Laws** database. ELAW partnered with Plastic Pollution Coalition, Break Free From Plastic Europe, and The Surfrider Foundation U.S. to build this powerful new database.

Global Plastic Laws will be the most comprehensive tool to date to research plastic legislation that has been adopted around the world. The database will track legislation across the full life cycle of plastics and organize policies according to life cycle categories and key topics. Adopting laws to reduce plastic pollution on a global scale is widely recognized as a vital step to address this crisis and rein in the damage plastic pollution is doing to our communities, health, and environment. Following the adoption of the UN Plastics Treaty, this database will support and monitor implementation.
